On receipt of the said reply/representation, the Authorities concerned is directed to consider the same and pass appropriate orders on merits and in accordance with law as expeditiously as possible.

4. With the above direction, the writ petition is disposed of. Consequently, connected miscellaneous petitions are closed. No costs.
