ORDER

3. Though the prayer in this Writ Petition is for a larger relief, the learned counsel for the petitioner has confined his argument to the limited extent of directing the 3rd respondent to consider and dispose of the representation of the Petitioner dated 2.5.2016, expeditiously. Considering the

limited prayer now sought for by the learned counsel for the petitioner, without going into the merits of the case, the 3rd respondent is directed to consider and dispose of the representation of the petitioner dated 2.5.2016, on merits and in accordance with law, within a period of three months from the date of receipt of a copy of this order.

4. With the above directions, this Writ Petition is disposed of. No costs.
