Prayer: Petition filed under Article 226 of the Constitution of India, praying to issue a WRIT OF HABEAS CORPUS, to call for the entire records relating to the impugned order of detention, passed by the second respondent, in Memo No.616/BCDFGISSSV/2016, dated 29.6.2016 and to set aside the same and consequently, to direct the respondents to produce the detenu, Pori @ Kutty @ Jayaprakash, aged about 22 years, petitioner's son, now confined in the Central Prison, Puzhal-I, Chennai, before this Court and to set him at liberty, forthwith.

ORDER

[Order of the Court was made by M.JAICHANDREN,J]

This Habeas Corpus Petition has been filed, by the father of the detenu, namely, Pori @ Kutty @ Jayaprakash, aged about 22 years, son of Ramesh, praying that this Court may be pleased to issue a Writ of Habeas Corpus, to call for the records, in BCDFGISSSV No.616/2016, dated 29.6.2016, passed by the second respondent, detaining the detenu under Section 3(1) of the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Cyber Law Offenders, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 (Tamil Nadu Act 14 of 1982), branding him as a "Goonda", in the Central Prison, Puzhal, Chennai and to quash the same and to direct the Respondents to produce the body of the detenu and to set him at liberty, forthwith.

2. We have heard the learned counsel appearing on behalf of the petitioner and the learned Additional Public Prosecutor appearing on behalf of the State and we have also perused the records, carefully.

3. Though, several grounds had been raised by the petitioner, while challenging the impugned order of detention, dated 29.6.2016, the learned counsel, appearing on behalf of the petitioner, had submitted that, in the booklet furnished to the detenu, page Nos.101 to 104, which are the statements of witnesses, are found illegible. Hence, the detenu had been prevented from making an effective representation against the impugned order of detention, dated 29.6.2016. Thus, the detention order is vitiated and the same is liable to be quashed.

4. The said submission made by the learned counsel appearing on behalf of the petitioner, had not been refuted by the learned Additional Public Prosecutor appearing on behalf of the respondents.

5. A perusal of the booklet supplied to the detenu, would show that page Nos.101 to 104, which are the copies of the statements of the witnesses, are illegible. As such, we find that the furnishing of the illegible copies of the statements of the witnesses, would prejudice the detenu, in making an effective representation against the impugned order of detention, dated 29.6.2016. Therefore, we are inclined to set aside the impugned detention order.

6. Accordingly, the Habeas Corpus Petition is allowed and the impugned detention order, dated 29.6.2016, passed by the second respondent is set aside. The detenu is directed to be released forthwith, unless his presence is required in connection with any other case.
