This Habeas Corpus Petition is taken up for hearing today, pursuant to the representation made by the learned Additional Public Prosecutor, to the effect that the Police secured the detainee and she is being produced before the Court today.

2. Heard the learned counsel for the petitioner and the learned Additional Public Prosecutor appearing on behalf of the State.

The detainee is now prepared to go with the petitioner, who is none other than her biological father. The petitioner, who appeared before us, submitted that he is prepared to take the detainee.

4. The minor was put in the Child Welfare Committee, Tiruvallur, by police, and she is produced from the said home today.

5. The custody of the detainee viz., Ms.Pavithra is handed over to the petitioner.

6. We direct the President, Child Welfare Committee, Tiruvallur, to make an entry with regard to the handing over of the custody of the minor viz. Pavithra to the petitioner.

7. The Habeas Corpus Petition is closed with the above observation.
