Prayer: Petition is filed under Article 226 of the Constitution of India, praying to issue a WRIT OF HABEAS CORPUS directing the respondents to produce the corpus of the detainee, namely, minor Chitra, Daughter of Maruthamalai, aged about 17 years, before this Court and to set her at liberty.

ORDER

[Order of the Court was made by S. BASKARAN, J.]

The petitioner, who is the uncle of the detainee, has come forward with this petition seeking a direction to the respondents to produce the detainee, namely, minor Chitra, who is missing from 30.10.2016.

2. The petitioner has stated that a complaint was lodged on 2.11.2016 by the mother of the detainee. Again, the petitioner had lodged a complaint through online, on 5.11.2016. As no effective steps had been taken to secure the detainee, he has come forward with this petition.

3. Today, when the matter was taken up for hearing, the minor detainee was produced by the second respondent police. The petitioner and his counsel, as well as the parents of the detainee are also present.

4. Admittedly, the detainee is a minor, as her date of birth, in the transfer certificate, is shown as 19.4.1999.

5. On enquiry, she has stated that she had gone away from her house on her own due to some misunderstanding and stayed at Tiruppur. Now the detainee has expressed her desire to along with her parents, namely, Valliammal and Maruthamalai, who are her mother and father respectively. The parents of the detainee had also agreed to take their daughter along with them.

6. In such circumstances, the detainee, namely, minor Chitra, is permitted to go along with her parents, namely, Valliammal and Maruthamalai, who are her mother and father respectively. Hence, no further orders are necessary in this Habeas Corpus Petition. Accordingly, the Habeas Corpus Petition stands closed.

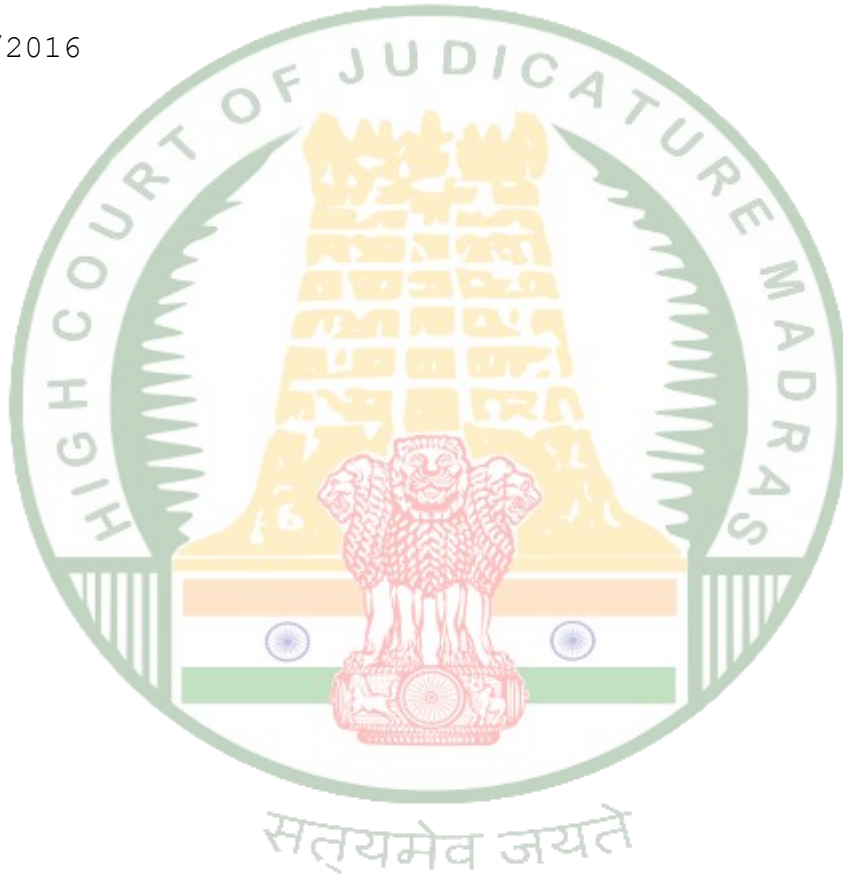
