2.The learned Additional Public Prosecutor appearing for the respondents would submit that the order of detention passed by the first respondent as against the husband of the petitioner dated 14.01.2016 has been revoked by the Government in G.O. [Rt] No.96, Food and Consumer Protection (E1) Department, dated 20.02.2016 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.

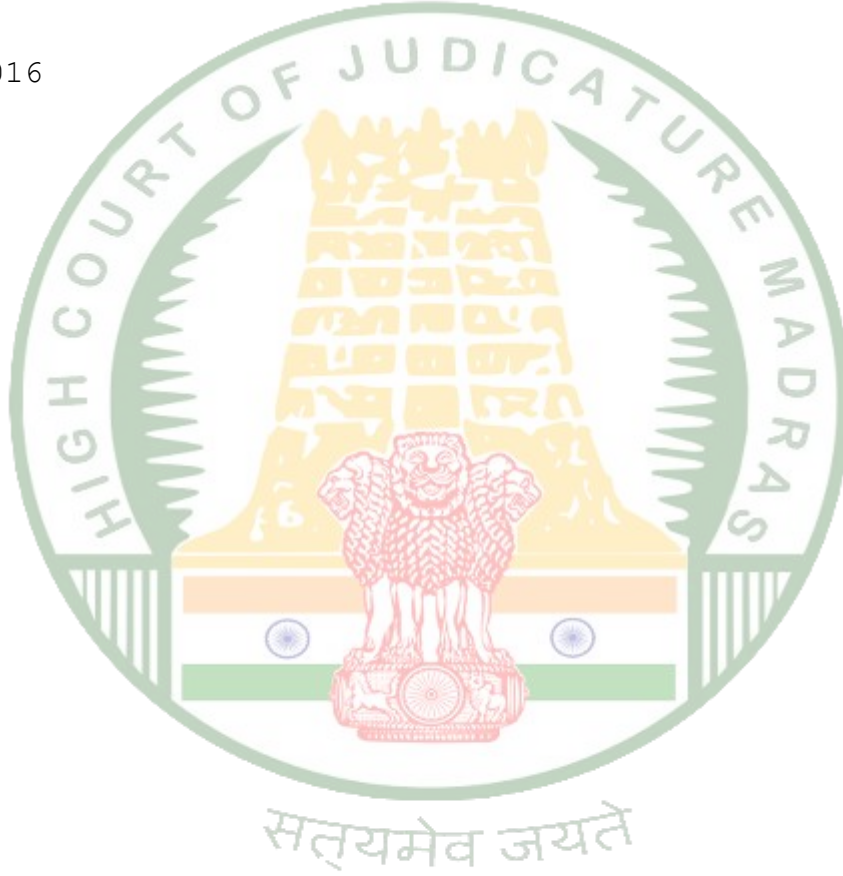
