The petitioner, who is the sister of the detenu, namely, Velu, aged about 38 years, son of Annappan, has come forward with this petition challenging the detention order passed by the second respondent dated 05.02.2016 against her brother branding him as a "Goonda" under Section 3(1) of the Tamil Nadu Prevention of Dangerous Activities of Bootleggers,

Cyber Law Offenders, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Sexual Offenders, Slum Grabbers and Video Pirates Act, 1982 [Tamil Nadu Act 14 of 1982].

2. The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the brother of the petitioner dated 05.02.2016 has been revoked by the Government in G.O.Rt.No.1356, dated 28.03.2016 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, the Habeas Corpus Petition is dismissed as infructuous.
