The learned Additional Public Prosecutor appearing for the respondents would submit that the order of detention passed by the third respondent as against the son of the petitioner dated 09.02.2016 has been revoked by the Government in G.O. [Rt] No.1359, Home, Prohibition and Excise (X) Department, dated 28.03.2016 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.

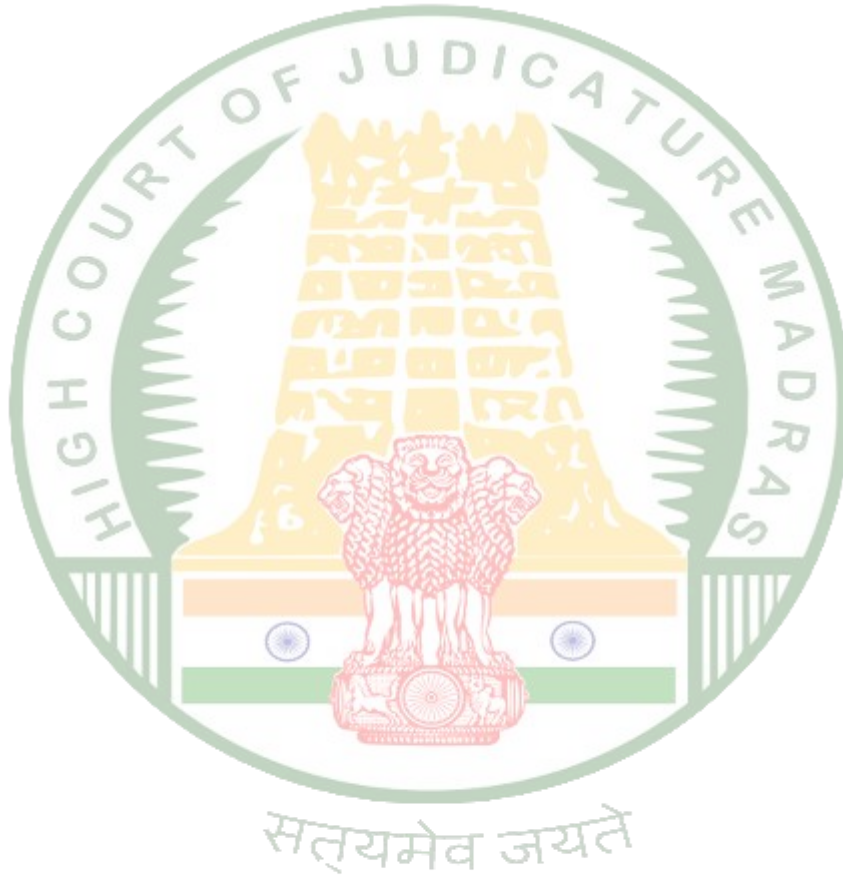
