Appeal under Clause XV of the Letters Patent filed against the order of the learned single Judge dated 13.6.2016 made in W.P.Nos.24669 & 24670 of 2015. to call for the records of the 6th respondents impugned order issued in Na.Ka.No.10/2015 dt.21.7.2015 and quash the same by directing the respondents not to disturb the petitioners in laying pipeline as per the order of the respondents by possessing the same for peaceful enjoyment of pumping water from S.Nos.233/2B & 2C to S.Nos.701/1, 701/3, 702/1, 702/4,, 797/2, 798/1 etc to an extent of 17.32 acres belong to petitioners.

WP.24670 of 2015 jto call for the records of the 6th respondents impugned order issued in Na.Ka.No.9/2015 dt.21.7.2015 and quash the same by directing the respondents not to disturb the petitioner in laying pipeline as per the order of the respondents by possessing the same for peaceful enjoyment of pumping water from S.Nos.233/2B & 2C to S.Nos.802/1 and 798/1 to an extent of 11 acres belonging to the petitioner.

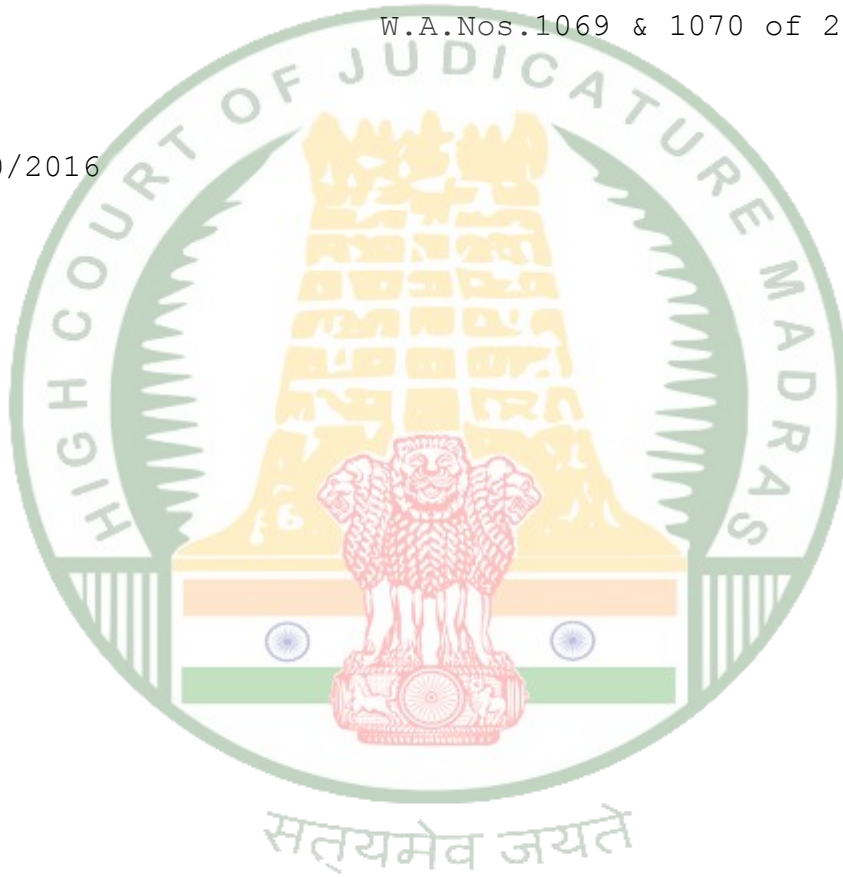
