2.The learned Additional Public Prosecutor appearing for the respondents 1 and 2 would submit that the order of detention passed by the second respondent as against the detenu dated 26.02.2016 has been revoked by the Government in G.O. [Rt] No.2220, Home Prohibition

& Excise (XIII) Department, dated 18.05.2016 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.

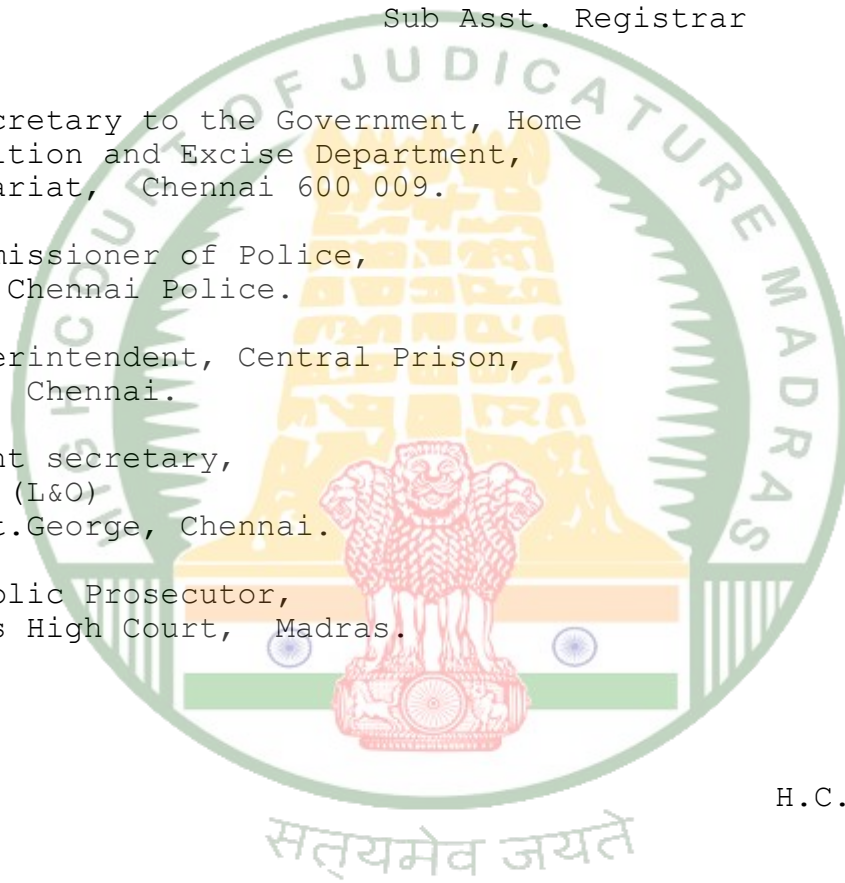
