Prayer : Petition filed under Article 226 of the Constitution of India praying for issuance of a writ of habeas corpus, call for the records in connection with the order of detention passed by the second respondent dated 24.02.2016 in BDFGISSV No.191/2016 against petitioner's husband, the detenu Thiru.Prabhu, S/o.Gopal, aged about 24 years, now confined at Central Prison, Puzhal, Chennai and set aside teh same and direct the respondents to produce the detenu before this Court and set him at liberty.

The petitioner, who is the wife of the detenu Prabhu, son of Gopal, aged about 24 years, has come forward with this petition, challenging the detention order passed by the second respondent dated 24.02.2016 against her husband branding him as a

"Bootlegger" as contemplated under Section 2(b) of the Tamil Nadu Act 14 of 1982.

2.The learned Additional Public Prosecutor appearing for the respondents 1 and 2 would submit that the order of detention passed by the second respondent as against the husband of the petitioner dated 24.02.2016 has been revoked by the Government in G.O. [Rt] No.2167, Home, Prohibition & Excise (X) Department, dated 18.05.2016 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.
