The petitioner, who is the wife of the detenu Vinay Kumar, son of Chinnadurai, aged about 34 years, has come forward with this petition, challenging the detention order passed by the second respondent dated 17.02.2016 against her husband branding him as a "Bootlegger" as contemplated under Section 2(b) of the Tamil Nadu Act 14 of 1982.

2.The learned Additional Public Prosecutor appearing for the respondents 1 and 2 would submit that the order of detention passed by the second respondent as against the husband of the petitioner dated 17.02.2016 has been revoked by the Government in G.O. [Rt] No.2301, Home, Prohibition & Excise (X) Department, dated 19.05.2016 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.
