ORDER

(Order of the Court was made by S.NAGAMUTHU, J.)

On the allegation, that these three are illegally detained by the third respondent, who is the father of the said Sabeena Anjum, the petitioner has come up with this Habeas Corpus Petition.

4. Having heard the said submission of the learned counsel for the 3rd respondent, the learned counsel for the petitioner would submit that the petitioner would work out his remedy before the Family Court.

5. The said submission is recorded. In view of the above, nothing survives in this petition and the petition is therefore, dismissed.
