This exercise be undertaken within a total period of three (3) months from the date of receipt of the order.

2.Writ petition, accordingly, stands disposed of. No costs.

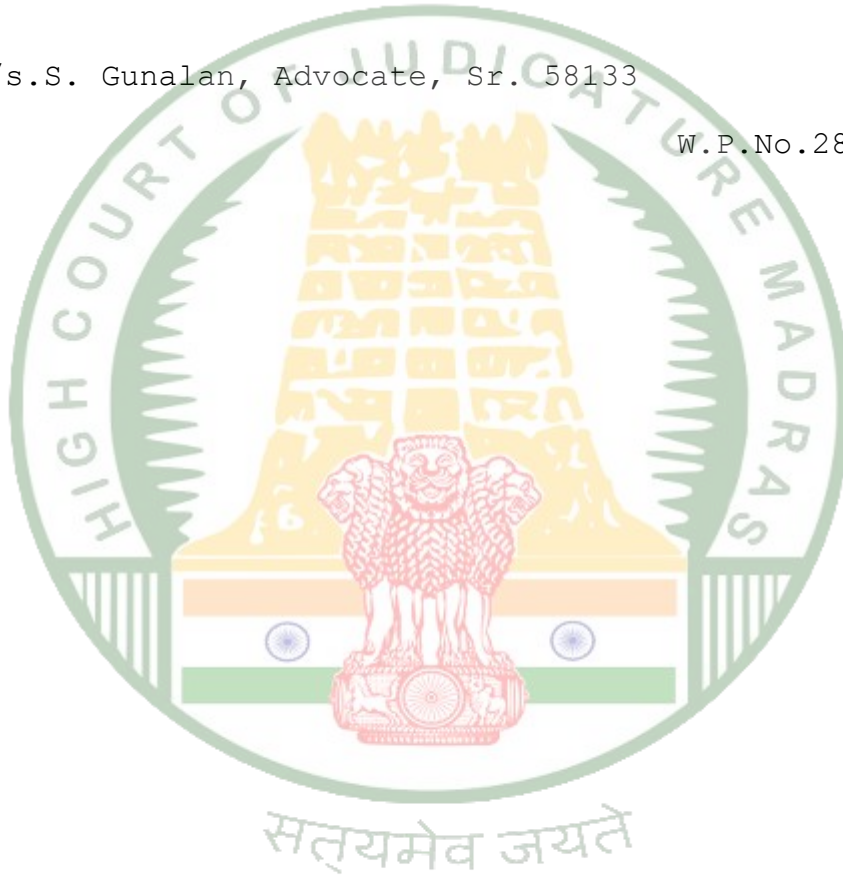
