2. It is the case of the petitioner that she is the owner of the disputed property, and respondents 2 and 3 are causing disturbance to her. Hence, the petitioner has approached this Court with the above prayer.

3. However, on the complaint given by the petitioner,

petition enquiry is pending in CSR.No.163 of 2016 and that the petitioner is not co-operating with the police for enquiry. Under such circumstances, the petitioner is directed to co-operate with the police and the respondent police is directed to call all the parties and conduct enquiry in CSR.No.163 of 2016 and take action in accordance with law.
