The petitioner has sought for a direction to quash the notification/Advertisement No.04/2013 dated 28.05.2013 calling for recruitment for the post of Assistant Professor in 'Indian Culture and Tourism'.

2. The learned Government Advocate on instructions would submit that the said recruitment has been completed and the selection list for 1093 post including subject "Indian Culture" has been sent to the Government on 17.04.2015 itself.

3. In view of the subsequent developments, the prayer sought for in the Writ Petition has become infructuous. Accordingly, the Writ Petition is dismissed. No Costs. Consequently, connected Miscellaneous Petitions are closed.

4. It is needless to point out that, if the petitioner is aggrieved upon the selections made against the notification of the Teachers Recruitment Board, it is open to him to challenge the same in the manner known to law.
