2. In view of the above, the civil suit is dismissed as withdrawn. No costs. Consequently, all connected pending applications are also dismissed.

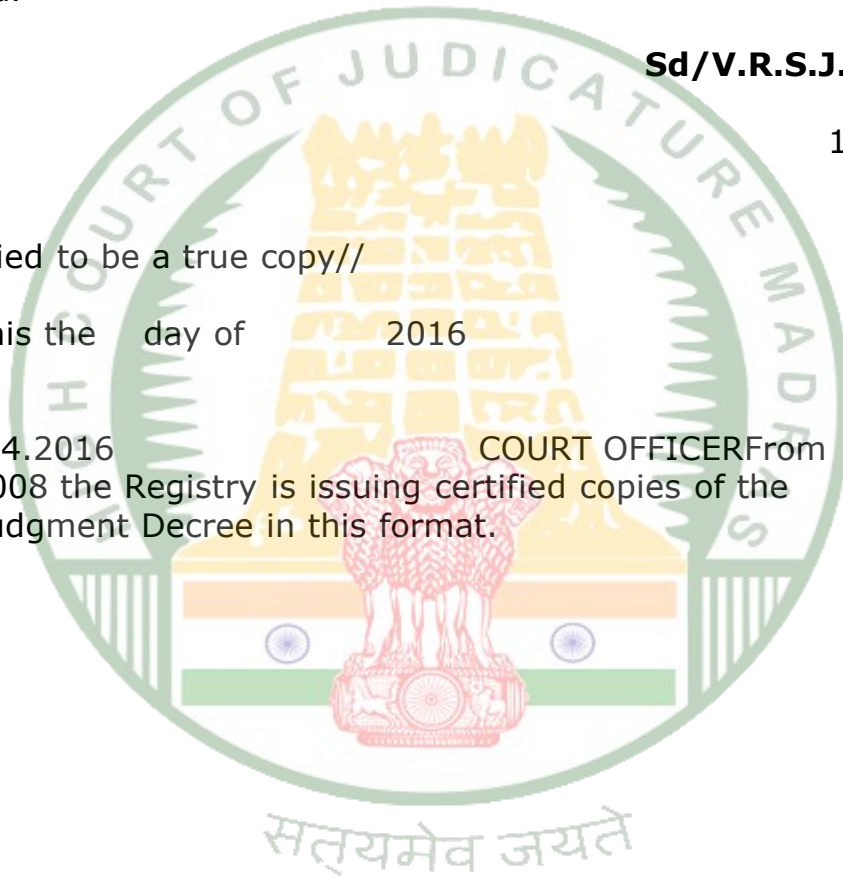
