4. The petitioners are victims in the cases registered, that are being investigated by the respondent police in Crime Nos.403/2012, 437/2012, 446/2012 and 531/2012 . If the petitioners, who are victims feel that asking for records is harassment by police, then the police may proceed further with the investigation with the available records and file the final report before the concerned Court instead of summoning the petitioners for records. A copy of this order may also be filed along with the final report.
