3. Learned Special Government Pleader appearing for the respondents would submit that the remedy for the petitioner is to file an appeal before the appellate authority. The petitioner has already filed an appeal before the appellate authority and now, it appears that the appellate authority has also passed an order. But, till date, the order copy has not been served.

4. Recording the same, the Writ Petition is closed with liberty to the petitioner to challenge the order of the appellate authority, if she is so aggrieved. No costs. Consequently, connected Miscellaneous Petition is also closed.
