Prayer in W.P.No.31187 of 2016 :-Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus to direct the Secretary to the Government of Tamil Nadu, Revenue Department, the First Respondent, to consider the petitioner's representation dated 28.07.2016 and to initiate action for inclusion of the petitioner's property of land measuring 4000 square feet (398.06 sq.metres) bearing Plot No.16, Mount Poonamallee Main Road, Old Survey No.435/1, New Survey No.435/1B(Very old Survey No.48) of St.Thomas Mount, Alandur Taluk, Kancheepuram District, in the Schedule-I or II of the Tamil Nadu Levy of Ryotwari Assessment on Free Hold Lands, 1972, and for issuance of patta in the petitioner's name in respect of the said property.

Prayer in W.P.No.31188 of 2016 : Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus to forbear the Sixth and seventh respondents, their men or subordinates, from interfering, in any manner whatsoever, with the peaceful possession of the petitioner's property of land measuring 4000 square feet (398.06 metres)

bearing Plot No.16, Mount Poonamallee Main Road, Old Survey No.435/1, New Survey No.435/1B(Very old Survey No.48) of St.Thomas Mount, Alandur Taluk, Kancheepuram District, except by due process law.

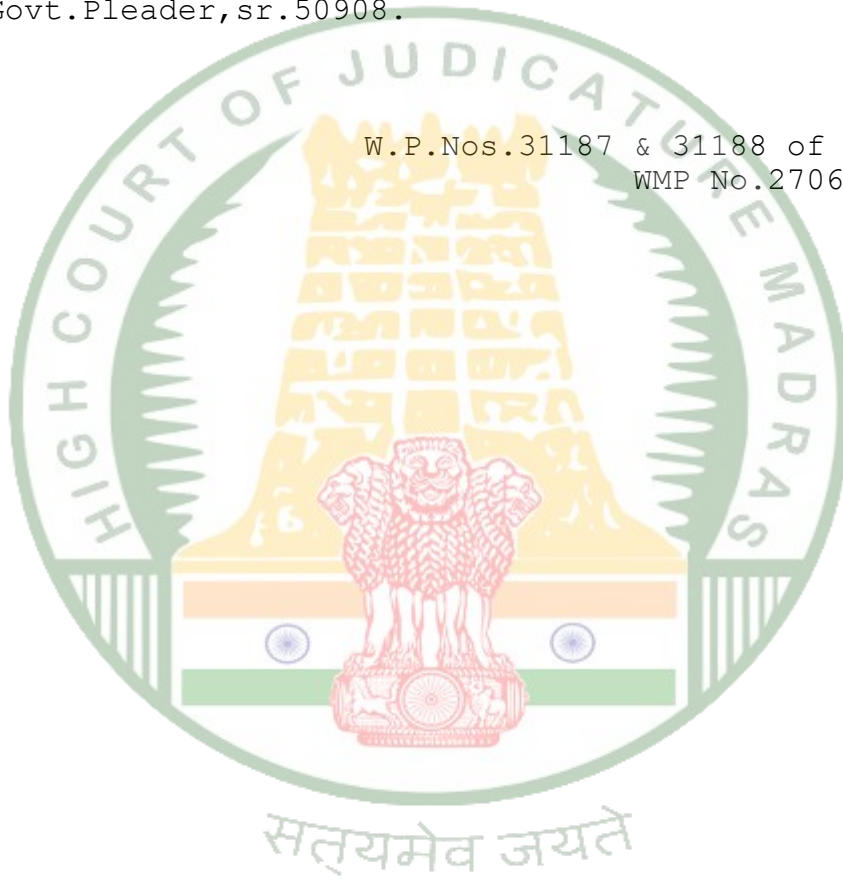
