3. We, thus, call upon respondent No.15 to carry out an
inspection of the site within fifteen days from the date of
receipt of the copy of this order and the encroachments, if any,
be removed in accordance with law, after notice to all concerned
and the proceedings completed within a maximum period of three
months thereafter.

4. The writ petition, accordingly, stands disposed of. No
costs.
