on the basis of the complaint given by the petitioner, as enquiry is going on in CSR/1451/H8/2015, the 2nd respondent is directed to expedite the enquiry and follow the dictum laid down in Lalitha Kumari vs. Govt. of U.P & others [2013 (4) Crimes 243 (SC) and register a case, if any cognizable offence is made out.
