ORDER

The petitioner has come forward with this petition seeking a direction to the respondents to provide police protection to the petitioner's vehicles, while unloading ration items in the ration shops situated in the respondents police jurisdiction.

But the respondents have not come forward to give police protection or enquire the same. Therefore, the petitioner has come forward with this petition for the above stated relief.

4.Considering the rival submissions made on both sides, the respondents are directed to consider the representation given by the petitioner dated 16.02.2016 and pass appropriate orders on merits and in accordance with law, within a period of two weeks from the date of receipt of a copy of this order.

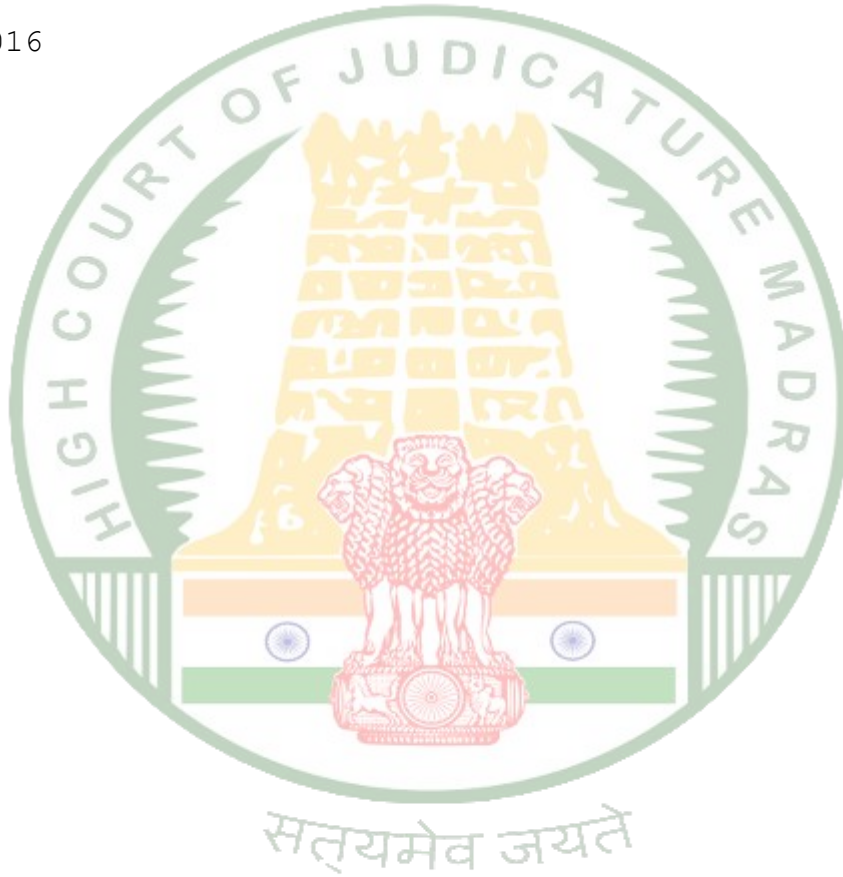
