After some arguments, the learned counsel for the petitioner

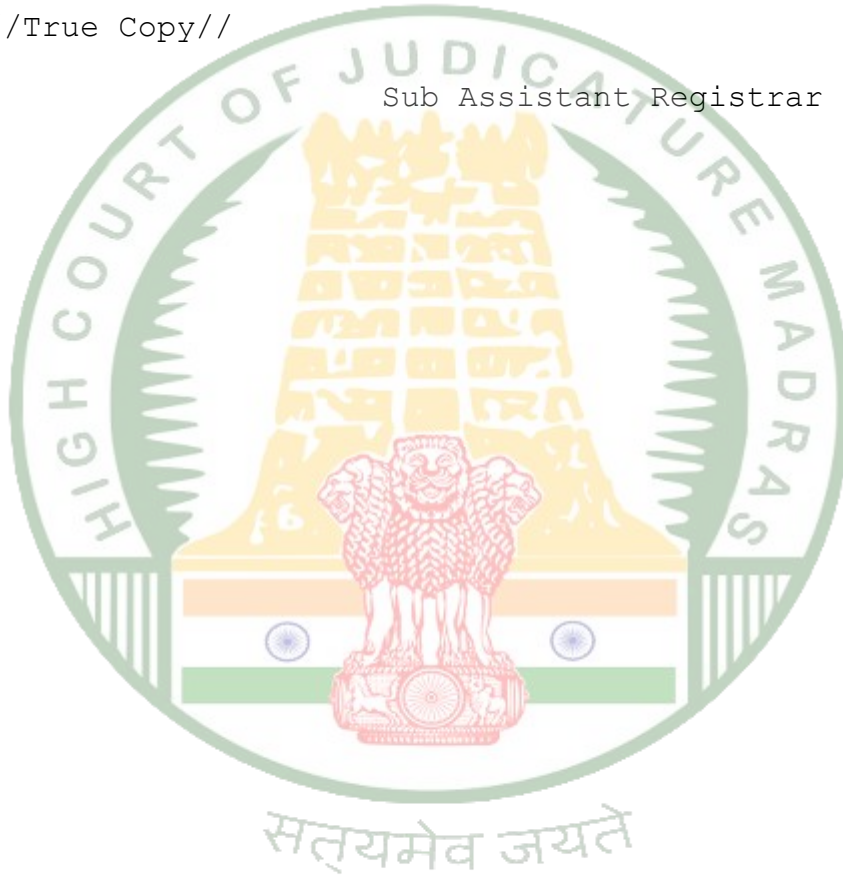
seeks to withdraw the petition as inter se disputes in respect of the family are already pending before the Civil Court.

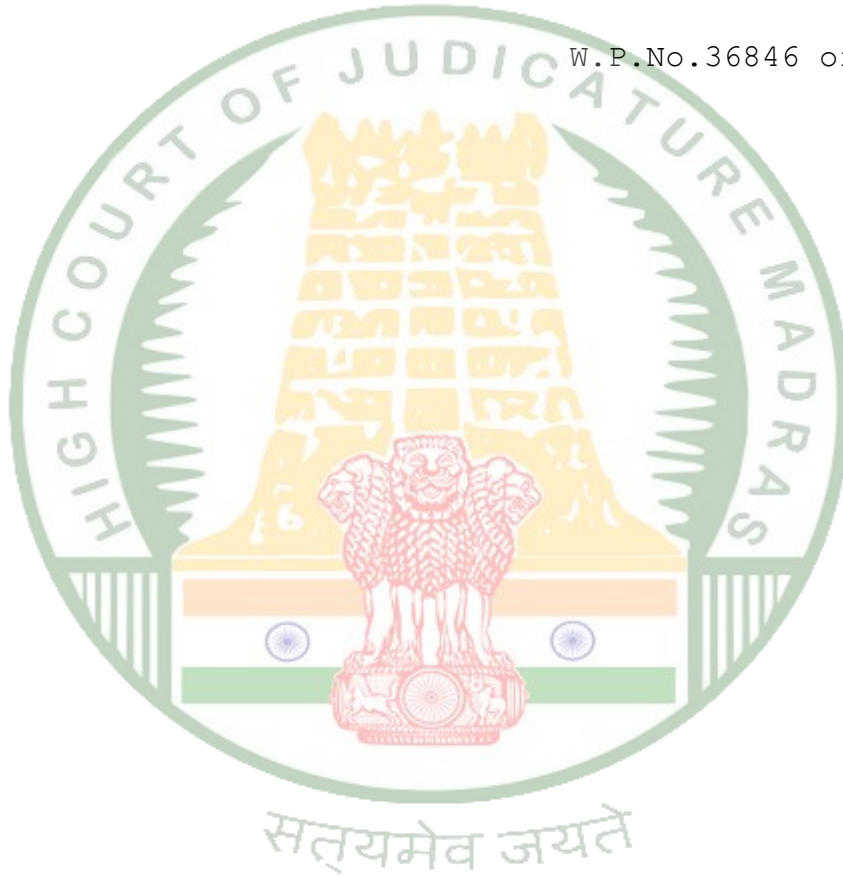
