4.Considering the rival submissions made on both sides, the petitioner is directed to appear before the Inspector of Police, G-2, Uthiramerur Police Station, Kancheepuram District along with relevant document on 06.04.2016 and the Inspector of Police, G-2, Uthiramerur Police Station, Kancheepuram District is directed to expedite the enquiry and follow the dictum laid down in Lalitha Kumari vs. Govt. of U.P & others [2013 (4) Crimes 243 (SC)] and register a case, if any cognizable offence is made out.

5.With the above direction, this Criminal Original Petition is disposed of.
