ORDER

The petitioner having made the allegation of encroachment of school land in the year 2009 has kept silent for six years before re-starting the process vide the representation dated 11.12.2015. The petitioner having slept over the matter, we are not inclined to entertain the petition at the behest of the petitioner.

2. However, in so far as the aspect of any encroachment on school land is concerned, it is expected that the concerned authorities will carry out an inspection and if the encroachment is found, to take action in accordance with law within a maximum period of three months of the receipt of the copy of this order.

3. The writ petition is dismissed with the aforesaid direction. No costs.

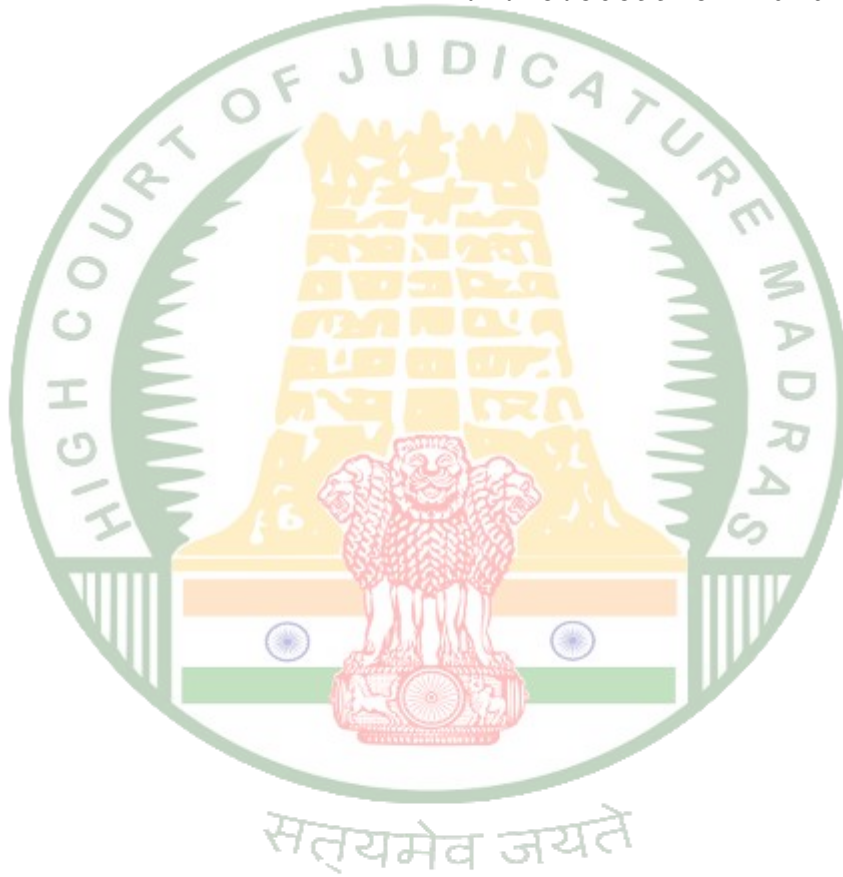
