2.Heard the learned counsel appearing for the petitioner and perused the typed set of papers.

3.At this juncture, the learned Additional Public Prosecutor, on instructions, would submit that the complaint given by the petitioner is pending before the third respondent. He further submitted that the petitioner has not co-operated for enquiry.

4.Considering the rival submissions made on both sides and as the complaint given by the petitioner is pending before the third respondent, the third respondent is directed to expedite the enquiry and follow the dictum laid down in Lalitha Kumari vs. Govt. of U.P & others [2013 (4) Crimes 243 (SC) and register a case, if any cognizable offence is made out. The petitioner is directed to appear before the third respondent on 25.04.2016 for enquiry.

5. The Criminal Original Petition is disposed of with the above direction.
