2.The learned counsel for the petitioner submitted that the petitioner has lodged a complaint before the respondent police on 02.03.2016, but the respondent has not shown any interest to enquire the matter and register the case. Hence, the petitioner has come forward with this petition for the above stated relief.

3.At this juncture, the learned Additional Public Prosecutor, on instructions, would submit that complaint given by the petitioner was acknowledged in C.No.917/COP/Visitors/2015 dated 02.03.2016 and it was forwarded to the All Women Police Station, Tambaram and enquiry is going on.

4.Considering the rival submissions made on both sides, on the basis of the complaint given by the petitioner as investigation is going on, the Inspector of police, All Women Police Station, Tambaram is directed to expedite the enquiry and follow the dictum laid down in Lalitha Kumari vs. Govt. of U.P & others [2013 (4) Crimes 243 (SC)] and register a case, if any cognizable offence is made out.

5.With the above direction, this Criminal Original Petition is disposed of.
