ORDER

Heard both sides.

2.The petitioners, who apprehend arrest for the offences punishable under Sections 147, 148, 341, 324, 294(b) and 506(ii) of I.P.C. r/w. Section 3(i)(x) of S.C & S.T Act in Crime No. 157 of 2016 on the file of the respondent police, move this petition seeking a direction to the learned Principal District and Sessions Judge at Thiruvanamalai (Special Judge of S.C & S.T), to accept the surrender of the petitioners and consider their bail application on the same day on merits.

3.Perused the records.

4.The offences complained of, other than the offence under the Special enactment, may not be serious in nature warranting initial detention in jail, even before considering the bail application.

5.Therefore, the learned Principal District and Sessions Judge at Thiruvanamalai (Special Judge of S.C & S.T), is directed to accept the surrender of the petitioners and consider their bail application on the very same day purely on the basis of merits and in accordance with law.

6.Accordingly, this Criminal Original Petition is ordered.
