

Crl.O.P.No.8920 of 2016

K.KALYANASUNDARAM, J.

The petitioners apprehend arrest at the hands of the respondent police for the alleged offences punishable under Sections 341, 294(b) and 506(i) of IPC, in Crime No.697 of 2015 on the file of the respondent police and hence, seek anticipatory bail.

2.The case of the prosecution is that due to wordy quarrel, the petitioners attacked the defacto complainant and caused injuries.

3.The learned counsel for the petitioners submitted that the petitioners are innocent and they have been falsely implicated in this case and they have not committed any such offence as alleged by the prosecution.

4.The learned Government Advocate (Criminal side) appearing for the respondent submitted that no one sustained injury and that investigation is pending.

5.Considering the above facts and circumstances of the case and also considering that no one sustained injury, this Court is inclined to grant anticipatory bail to the petitioners with certain conditions.

7. Accordingly, the petitioners are ordered to be released on bail in the event of arrest or on their appearance before the learned VII Metropolitan Magistrate, George Town, Chennai and on each of them executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Magistrate concerned and the petitioners shall appear before the respondent police daily at 10.30 a.m. for a period of two weeks and thereafter as and when required for interrogation. The petitioners shall comply with the condition stipulated under Section 438 Cr.P.C. scrupulously.

8. The petitioners shall appear before the concerned Magistrate within a period of 15 days from the date on which the order copy made ready, failing which, the petition for anticipatory bail stands dismissed.
