2.We accede to the request and grant the aforesaid three (3) months period of time, whereafter the respondent authorities will re-inspect within a period of fifteen (15) days to confirm that the needful has been done, failing which they can forthwith proceed in pursuance to the notice.

3.Writ petition, accordingly, stands disposed of. No costs. Consequently, W.M.P.No.35115 of 2016 stands closed.
