## O R D E R

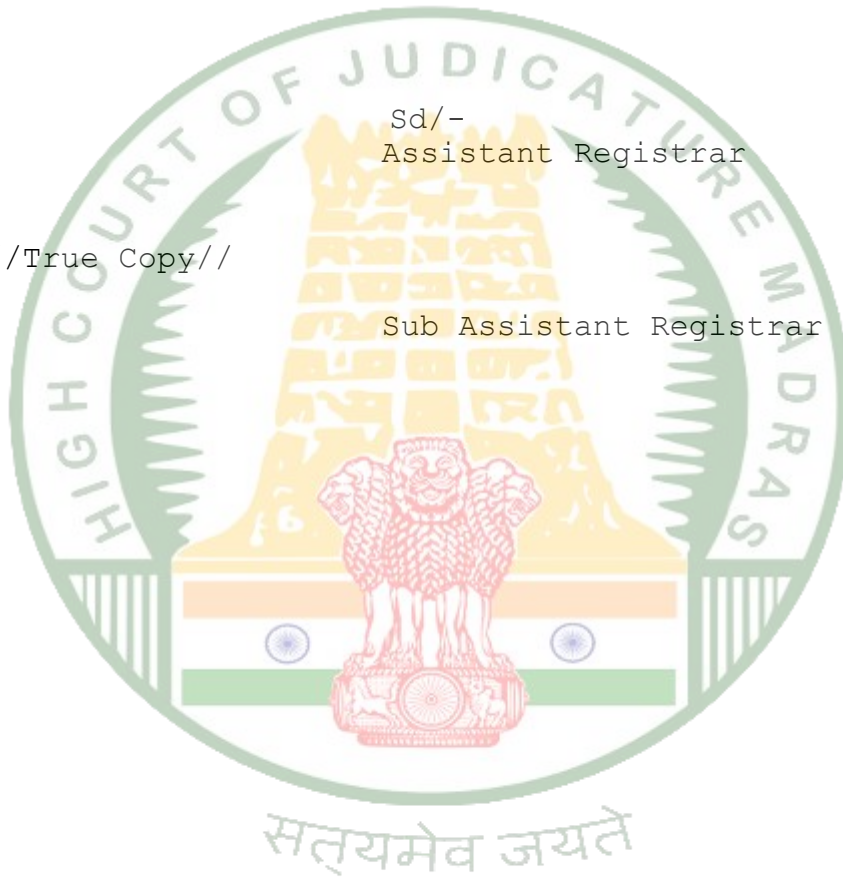

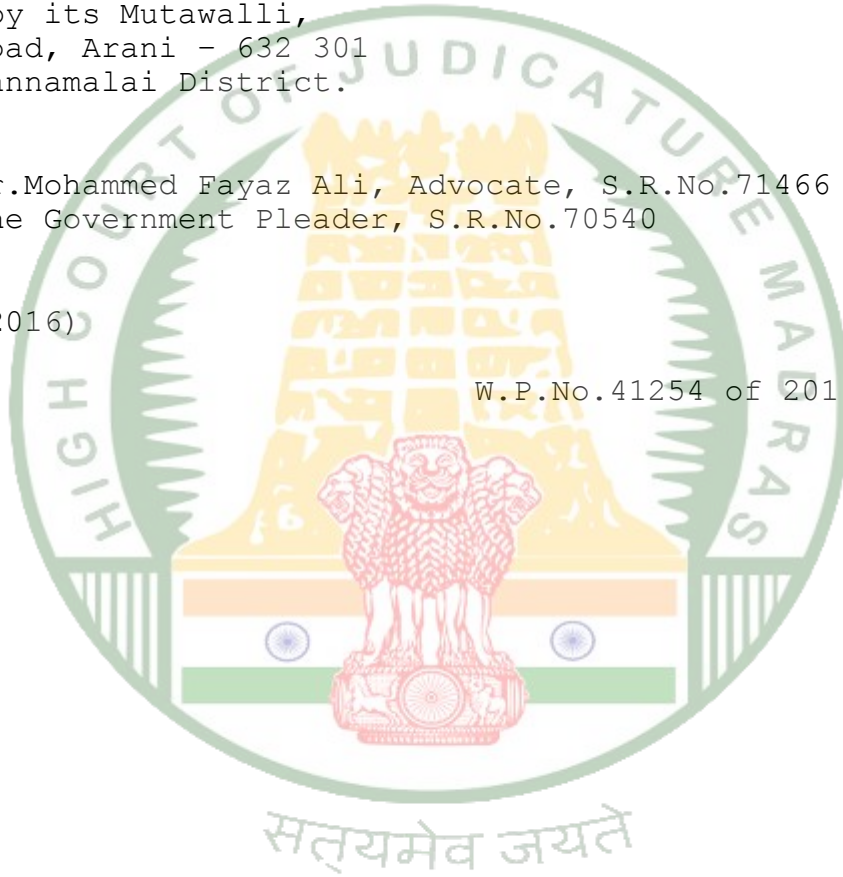
