St. George Cathedral Gopalapuram Chennai 86 (WP.43363/2016); and, at South Koovam Canal Road Near Park Egmore Chennai 8 (WP.43364/2016); wherein selling Tea, Coffee and Food items till the Township Vending Committee decides on the petitioners' representation dated 21.11.2016 (in WPs.43360, 43361, 43363 and 43364 of 2016 and dated 24.11.2016 in WP.43362 of 2016, as per the provisions of the Street Vendors (Protection of Livelihood Regulation) Act
