3. The writ petition, accordingly, stands disposed of. No costs.

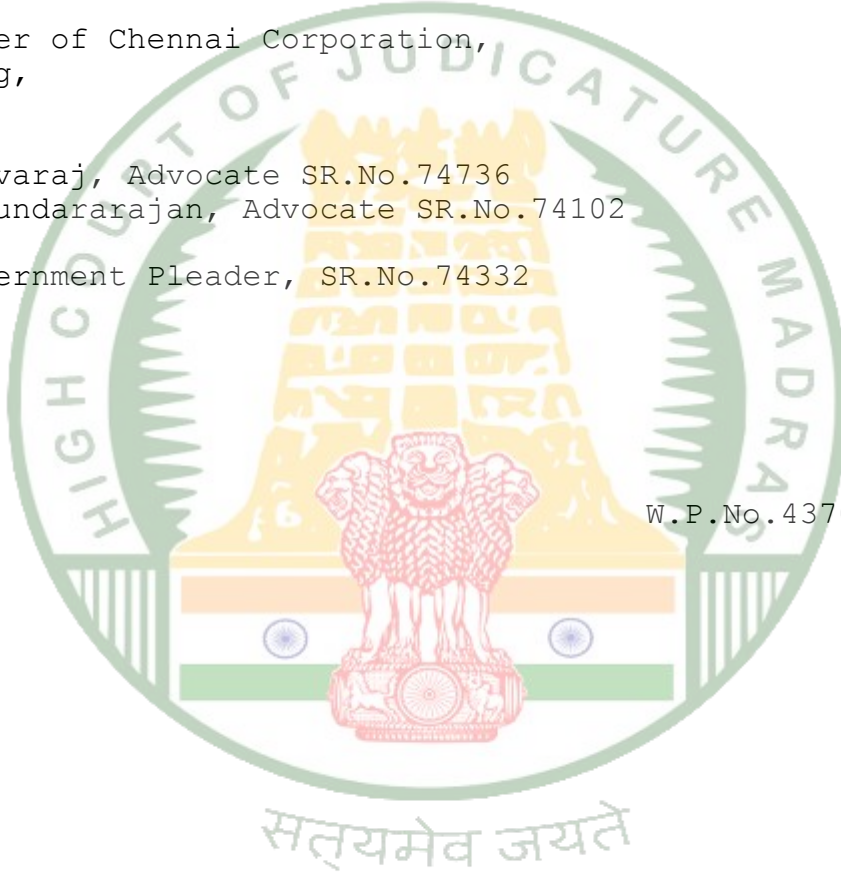
