In view of the aforesaid, the only direction to be passed is for the aforesaid representation of the petitioner to be disposed of by the Revenue Divisional Officer, Hosur/respondent No.2 within a maximum period of three months of the receipt of the copy of this order, after causing an inspection of the site within a period of fifteen days of the receipt of the copy of this order and on obtaining the report from the Tahsildar, Hosur/respondent No.3.

3. The writ petition, accordingly, stands disposed of. No costs. Consequently, W.M.P.No.37853 of 2016 is closed.
