This Court, considering the limited prayer sought for by the petitioner, without going to the merits of the matter, hereby directs the first respondent to consider the representation of the petitioner dated 14.10.2015 and pass appropriate orders in accordance with law within a period of four weeks from the date of receipt of a copy of this order. The writ petition stands disposed of accordingly. No costs.
