3.This Court is not able to consider the prayer sought for by the petitioner in this writ petition to give a direction to the Joint Registrar, Kanchipuram Division Co-Operative Society, Kanchipuram/first respondent herein, as the same is not legally maintainable by the ratio laid down by the Hon'ble Full Bench judgment of this Court in K.Marappan Vs. Deputy Registrar of Co-operative Societies, Namakkal reported in 2006 (4) CTC 689. Therefore, the writ petition fails and the same is dismissed. No costs. Consequently, connected M.P. is closed.
