ORDER

Heard the learned counsel for the petitioner ; Mr.M.L.Mahendran, learned Government Advocate accepting notice on behalf of the 1st respondent ; and Mr.P.V.Selvakumar, learned Standing Counsel accepting notice on behalf of the respondents 2 and 3 and with their consent, the writ petition is taken up for final disposal at the admission stage.

2 The petitioner is a physically challenged person and he has filed this writ petition to direct the respondents to consider his representations dated 12.12.2015 and 04.01.2016 seeking permission to put up a shop in a particular locality. The said representations are still pending before the authorities and therefore, the petitioner has approached this Court.

3 In the typedset of papers, the petitioner has filed the Disability Certificate to show that he is 60% disabled.

4 In the light of the above, there will be a direction to the 3rd respondent to consider the representations of the petitioner dated 12.12.2015 and 04.01.2016 on merits and in accordance with law and pass orders within a period of six weeks from the date of receipt of a copy of this order.

5 The writ petition is disposed of with the above direction. No costs.
