3.Learned Special Government Pleader appearing for the respondents submits that the impugned order dated 19 October 2015 has been recalled. She would submit that the State Level Scrutiny Committee will examine the matter afresh in the light of the guidelines laid down by a Division Bench of this Court wherein one of us (Satish K.Agnihotri, J.) was a Member, in G.Venkitasamy Vs. The Chairman, State Level Scrutiny Committee, Chennai¹.

4.In view of the foregoing, according to the learned counsel appearing for the petitioner, nothing survives for adjudication at this stage. Accordingly, the writ petition is disposed of. No costs.
