ORDER

This Court, considering the limited prayer sought for by the learned counsel for the petitioner, without going to the merits of the case, hereby directs the first respondent to dispose of the pending representations of the petitioner and for the said purpose, the petitioner is hereby directed to make a fresh representation along with a copy of this order within a period of one week from the date of receipt of a copy of this order and on receipt of the same, the first respondent is further directed to consider the same on merits and pass appropriate orders in accordance with law within a period of six weeks thereafter. The writ petition is disposed of accordingly. Consequently, W.M.P.No.6844 of 2016 is closed. No costs.

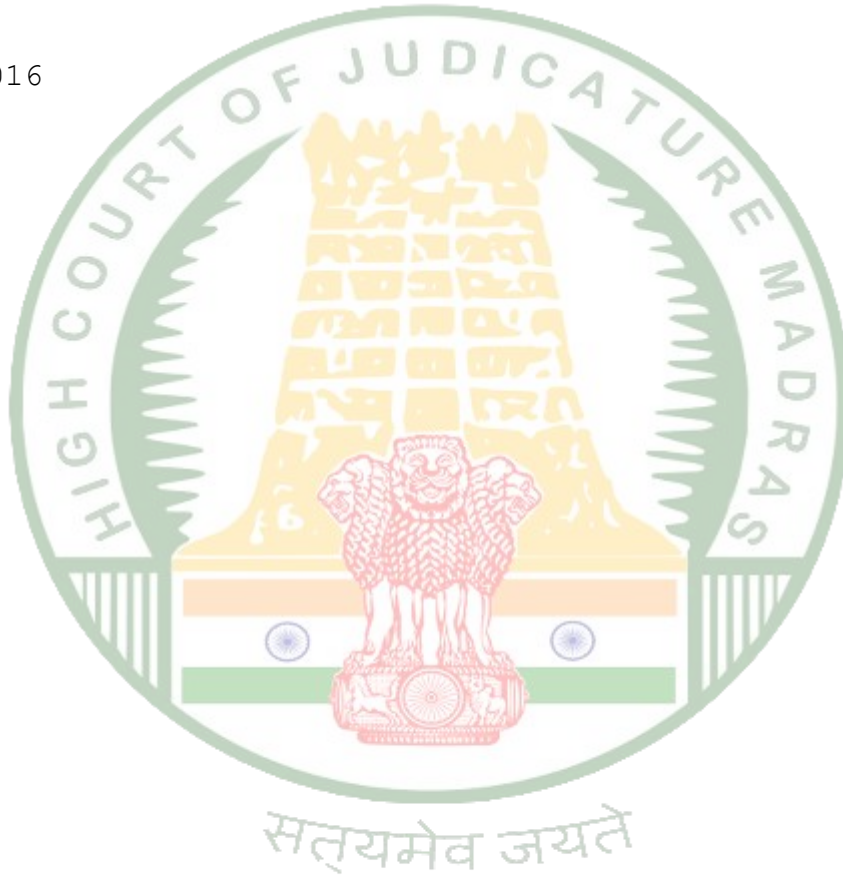
