2. Mr.M.S. Ramesh, learned Additional Government Pleader, takes notice for the respondent and submitted that the respondent may be directed to consider the petitioners' applications in accordance with law.

Having regard to the submissions made by the learned counsel on either side and taking into consideration the limited prayer sought for by the petitioners, without expressing any opinion with regard to the merits of the case, I direct the respondent to receive the respective applications of the petitioners dated 15.12.2015 (petitioners in W.P.Nos.8783 to 8786 of 2016) and 16.12.2015 (petitioners in W.P.Nos.8787 to 8790 of 2016) for the grant of Contract Carriage Maxi Cab permit and consider the same on merits and in accordance with law, within a period of four weeks from the date of receipt of a copy of this order.

4. With this observation, all the writ petitions are disposed of. No costs.
