O R D E R

(Order of the Court was made by The Hon'ble Chief Justice)

The matters pertain to the issue of exemption from taking examination in Tamil, which has already been dealt with by our order in W.P.No.1262 of 2016, etc. batch. dated 25.01.2016. The cut-off date was 07.12.2015 and there has been undisputedly some delays by the institutions in forwarding the applications. The delays are, however, of minimal time periods, as these applications have been received broadly on three different dates, i.e., 14.12.2015, 15.12.2015 and 17.12.2015. Thus, the delays are in the range of maximum period of ten days. Tamil Nadu was also affected by floods at the relevant stage of time and that has also created functional problems.

2.We believe that the fate of the students should not be affected by some delay in forwarding of the applications by the institutions, if they are otherwise eligible, which is the position in case of all these candidates.

3.In the counter-affidavit, which we have perused, the respondent authorities have expressed some difficulties on account of the process having been completed for the examination, but simultaneously it is not disputed that these are not insurmountable to facilitate the students to take the examination, which is now scheduled for tomorrow (15.03.2016).

4.We, thus, allow all these writ petitions and exempt them from taking the Tamil examination on parity with the order passed by us referred to aforesaid. The necessary paper work be carried out by the respondents to facilitate the students to take the examination tomorrow.

5.To prevent any unnecessary harassment to other students, who are similarly placed but may not have been able to approach this Court, so long as they approached the respondent authorities, i.e. Directorate of Government Examinations, today by 5.00 p.m., the benefit would be extended.

6.Writ Petitions, are, accordingly allowed in the aforesaid terms. No costs. Consequently, all the miscellaneous petitions are closed.
