The petitioner has filed the above Writ Petitions to issue writs of certiorari to call for the entire records relating to the orders dated 15.12.2015 passed by the 1st respondent and to quash the same.

2.Mr.A.P.Srinivas, learned Standing Counsel appearing for the respondent submitted that as against the impugned orders, the petitioner has got appeal remedy before the Tribunal, therefore, in the absence of any violation of principles of natural justice, the petitioner may be given liberty to file

appeals before the Tribunal.

3.The learned counsel for the petitioner submitted that two weeks time may be granted for filing appeals as against the impugned orders.

4.In view of the same, I direct the petitioner to file appeals as against the impugned orders dated 15.12.2015 within a period of two weeks from the date of receipt of a copy of this order. 5.With these observations, the Writ Petitions are closed. No costs. Consequently, the connected miscellaneous petitions are closed.
