No.1246 of 2009 dated 18.08.2010 and W.P. No.33975 of 2005 dated 20.09.2011 and in W.P. No.35674 of 2005 dated 20.09.2011 and in W.P. Nos.18866, 18887, 19394 to 19396 of 2014 dated 27.08.2014 and in W.P. No.11372 of 2015 dated 20.04.2015.

ORDER

The petitioner, P.Valli, whose husband, served as a Conductor from 26.02.1971 and retired under voluntary retirement scheme on 30.09.1997 and subsequently passed away on 08.08.2013, has come to this Court, seeking direction to the first respondent to grant Family Pension and payment of arrears of Family Pension from 09.08.2013, by following the judgment in W.A. No.1246 of 2009 dated 18.08.2010 and orders in W.P. No.33975 of 2005 dated 20.09.2011, W.P. No.35674 of 2005 dated 20.09.2011, W.P. Nos.18866, 18887, 19394 to 19396 of 2014 dated 27.08.2014 and in W.P. No.11372 of 2015 dated 20.04.2015.

2.In view of the judgment passed by this Court in W.A. No.1246 of 2009 dated 18.08.2010 in the case of A.Loganayaki, wife of late C.Ananatha Krishnan vs. the Secretary to Government, Transport Department and two others, which has been affirmed by the Apex Court in S.L.P. CC 8381/2011 dated 13.05.2011, the petitioner has made a representation on 14.01.2016. But the said representation to grant family pension and payment of arrears of family pension from 09.08.2013, has not been considered. Therefore, she is before this Court.

3.Heard the learned counsel appearing for the petitioner, the learned Additional Government Pleader appearing for the first respondent and the learned Standing Counsel appearing for the second respondent.

4.A perusal of the the pension payment order dated 13.06.2008 passed by the Accountant General (A&E) Chennai-18, shows that the petitioner's husband was receiving pension.

5.Considering the facts and circumstances of the case, without going into the merits of the same, this Court directs the first respondent to consider the petitioner's representation dated 14.01.2016, on merits and in accordance with law, in the light of the judgment passed by this Court in W.A. No.1246 of 2009 dated 18.08.2010, within a period of eight weeks from the date of receipt of a copy of this order.

6.With the above direction, the Writ Petition is disposed of. No costs.

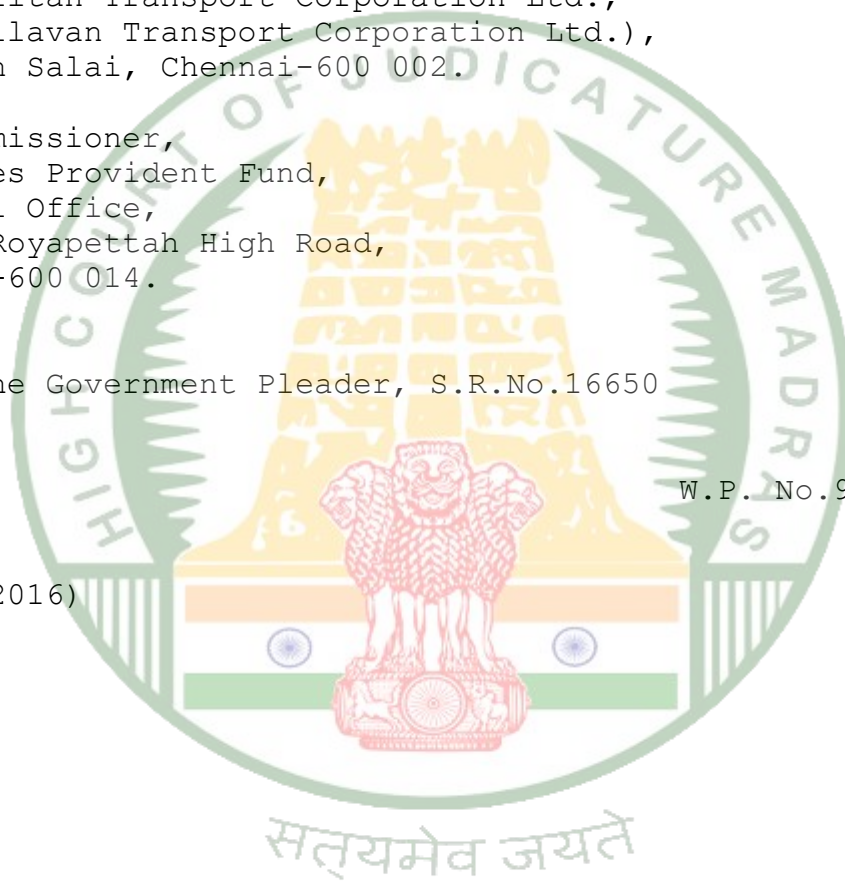
