4 That there be no costs in this Appeal.

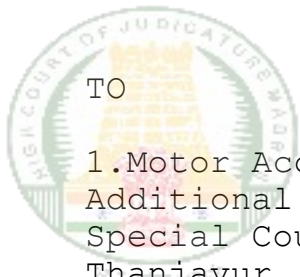
