4. that there be no costs in this Civil Miscellaneous Appeal.

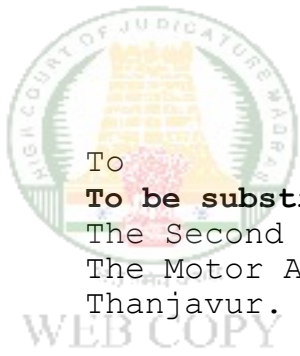
