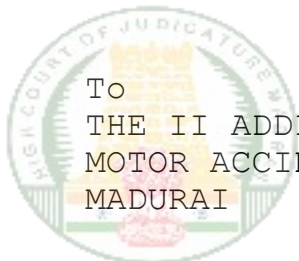
2. that the victim/claimant be and is hereby entitled to recover the award of compensation from the owner of vehicle in the manner known to law.
