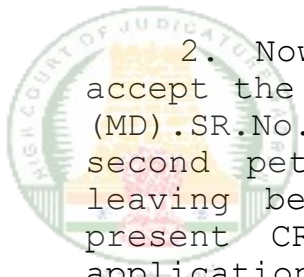

ORDER : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of M/S. K.GOVINDARAJAN, Advocate for the petitioner the court made the following order:-

The Civil Revision is petition in CRP(MD).SR.No.57161 of 2014 is filed to set aside fair and decretal order dated 15.07.2013 passed in CMA.No.12 of 2012 on the file of the IV Additional District Judge, Madurai confirming the fair and decretal order in I.P.No.35 of 2003 on the file of the III Additional Subordinate Judge, Madurai.



2. Now, the petitioners have filed the present petition to accept the cause title as shown in the Memorandum of grounds of CRP (MD).SR.No.57161 of 2014. It is seen from the records that the second petitioner Viz., Muthuraman Chettiyar died on 02.03.2014 leaving behind the petitioners 3 to 7 as his legal heirs. The present CRP was filed on 18.12.2014. Therefore, the present application is not maintainable.
