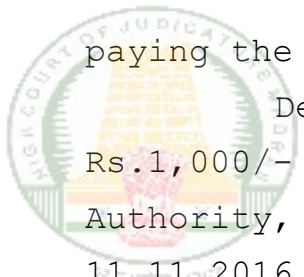
Prayer in CMA(MD) No.SR10808 of 2012:-
