Prayer in MP(MD). 1/ 2015 in WA(MD).SR28227/2015 :

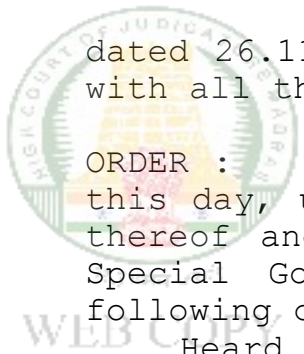
To condone the delay of 821 days in filing the above Writ Appeal and thus render justice.
